REPORT PERSUANT TO ART. 13 OF UE LAW DECREE 2016/679

1. PURPOSE OF PROCESSING

Persuant to Art. 13 of UE Law Decree 2016/679 regarding the treatment of personal data of natural persons, we inform that the treatment of personal data, that are provided during the execution of the required order or the existing contract between the parts, aims uniquely to accomplish the contractual obligations in order to fulfill the client's specific requests, as well as fulfill normative duties, in particular accounting and fiscal ones, other than provide commercial informations on our products and services.

2. TREATMENT MODALITIES

The treatment will occur via manual, informatic and telematic instruments with procedures strictly related to the purposes for which they are collected and in any case, in order to guarantee the safety and the privacy of the data themselves and in the respect of the European regulation of the matter.

3. NATURE OF THE PROVISION OF DATA AND CONSEQUENCES OF A POTENTIAL REFUSAL TO ANSWER

The data provision is necessary for the correct execution of the contractual and pre-contractual duties and their lack of indication entails the impossibility of completing, in the right way, the fulfillment of the contractual obligations a tour expense, other than the impossibility of being promptly updated with new products and services by our company, etc.

4. SCOPE OF COMMUNICATION AND DISSEMINATION OF DATA

Personal data can come to the attention of the appointees of the treatment.

Personal data will not be widespread, but they will be communicated to professional studies or companies since they are due for the fulfillment of our activity, as well as for the fulfillment of related regulatory and fiscal obligations and credit insitutions, financial offices. These figures are designated responsible of the treatment with written agreement, as disciplined by the Law Decree UE 2016/679.

6. RIGHTS OF THE SUBJECT

On persuant to Art. 15-22 of Law Decree UE 2016/679, Commerciale Fond S.p.A. informs that the subject has the right to obtain the identification (i) of origin of personal data; (ii) of the purposes and of the procedures of the treatment ; (iii) of the applied method in case of data treatment carried out with the aid of electronic devices; (iv) of the identification details of data controller and data processor; (v) of the subjects or category to whom personal data can be communicated or who can receive informations as data processors.

The subject has also the right of obtaining: a) the update, the rectification, that is the integration of the data, when it has a concern; b) the cancellation, the restriction of use, the transformation in anonymous form or the interdiction of the data processed in violation of the law, included the ones of which is not necessary the preservation in relation to the purposes for which the data were collected and successively treated; c) the statement that the operations of the letters a) and b) have been brought to the notice, even for their content, of those who the data were communicated or disseminated, except the case in which said fulfillment turns out to be impossible or it implicates the use of resources revealingly excessive compared to the protected right.

The subject has the right to object, totally or partially, to the treatment of personal data that concern him: a) for legitimate motives, even if the treated data were relevant to the purpose of the collection; b) for transmission of advertising material or direct sale or for the completion of market surveys or commercial communications.

The subject has the right to the portability of data, that is the right to receive from Commerciale Fond S.p.A., in a organised form, of common use and readable from an automatic device, the informations that concern him, and to transmit those informations to another data controller.

The subject has the right to revoke their given consent in every moment, except the validity of treatment realized before the revocation.
